Managed care for families, children, pregnant women, people with disabilities, complex care needs and qualifying adults under age 65.



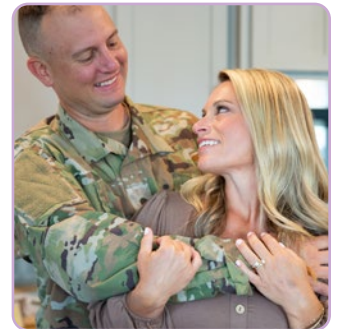
Marketplace

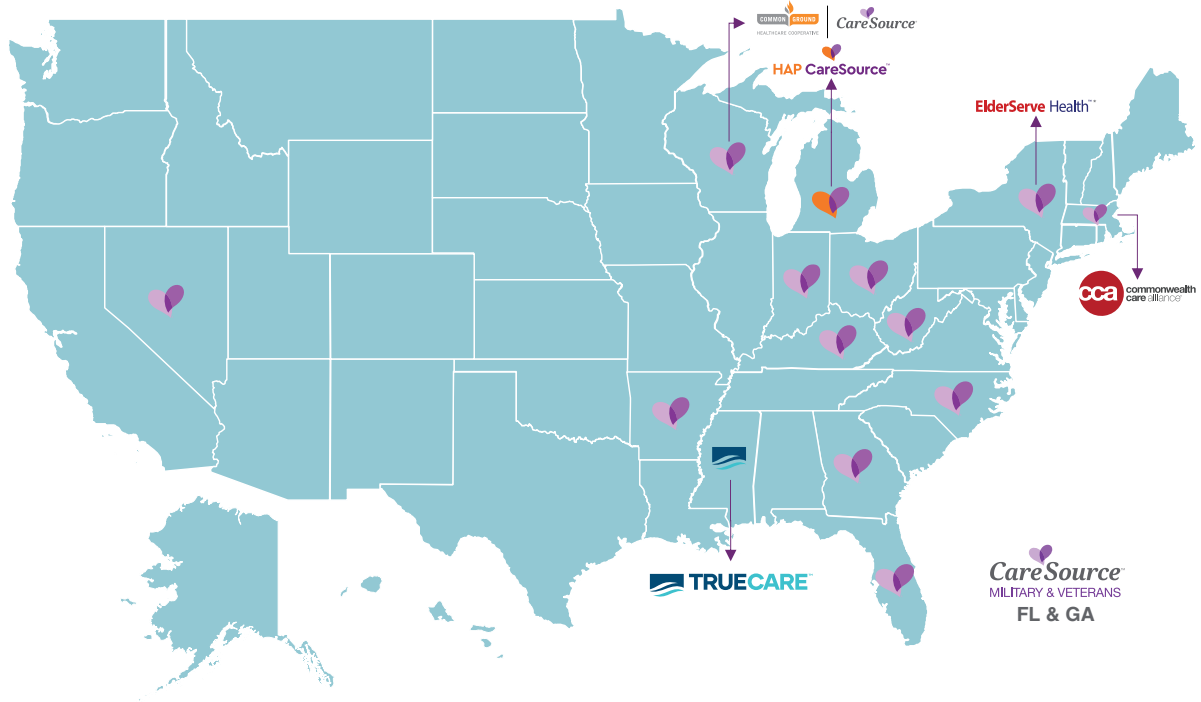
