# Summary

Remember – beginning on February 15, 2021, there will be a change of process for initiating oncology pre-certification requests for CareSource Marketplace members.

#### Impact

Eviti Connect electronically connects CareSource and oncology practices for the authorization of oncology treatment plans in real-time, validating cancer treatment decisions with evidence-based medicine before treatment begins. The automated process reduces the administrative time involved in obtaining and providing authorizations at the drug level and assures appropriate reimbursement at the regimen level, aligning all parties around value-based oncological care.

### Importance

\*\*All oncology treatment plans (i.e., chemotherapy and supporting medications) will need to be submitted to NantHealth via their web portal, Eviti Connect, which will expedite approval of any chemotherapy or supportive medications that require prior authorization.\*\*

#### About Eviti Connect web portal

Using the Eviti Connect web portal is the fastest and most efficient way to initiate requests for treatment authorization.

Typically, treatment entry takes less than 15 minutes and treatments that comply with evidencebased standards and CareSource plan language will receive an "Eviti code," indicating that CareSource is sending an approval letter. In some cases, you may even receive an Eviti code instantly.

If you do not receive an Eviti code instantly, Eviti's Medical Office is able to review and discuss the treatment with your office before referring it to CareSource for final determination. All determinations will be returned within 48 hours (24 hours for urgent cases).
