#### **Summary**

Thank you valued Health Partners for your continued participation with CareSource's Georgia Medicaid program. CareSource clinical teams understand that there may be cases where a member necessitates anesthesia or IV sedation and can appropriately and safely be served in their local dental office versus the hospital or with the assistance of a certified anesthesiologist. **Effective Jan. 1, 2023,** to streamline and align with Department of Community Health (DCH) policy, CareSource is requiring that MD Anesthesiologists submit all anesthesia claims for reimbursement using HCFA 1500 for physician services form, also known as CMS 1500 form. These claims should be submitted to CareSource, not the dental vendor (SKYGEN).

### **Impact**

To decrease contracting touchpoints and lessen administrative burden, CareSource contracts directly with both its dental and medical provider networks. If you are already currently contracted with CareSource under a dental provider agreement as an MD Anesthesiologist or group, you will just need to complete a signed amendment for medical services no later than Dec. 1, 2022, so we can ensure your group is properly configured before the Jan. 1, 2023 go-live. If you are a new MD Anesthesiologist or group, you will need to complete a new provider contract agreement which can be accessed at Contract with Us. If you are a MD Anesthesiologist or group employed directly by a dental group, please ensure your dental group payee ID is correct in GAMMIS for all Medicaid providers to ensure remits/claims payments are sent to the correct payee.

#### **Importance**

Providers should implement the new billing policy no later than Jan. 1, 2023. The following resources may be helpful:
