Subject: 2025 Order, Prescribe and Refer (OPR) Update – REVISION

Effective Date: February 1, 2025

This notification is an update to the <u>network notification</u> posted on January 31, 2025. Updates are outlined in red font.

Summary

Effective 2013, the Georgia Medicaid program required certain providers who order, prescribe and refer (OPR) items or services for Medicaid beneficiaries to be enrolled as an OPR provider for the distinct purpose of ensuring all orders, prescriptions or referrals for items or services for Medicaid beneficiaries originate from appropriately-licensed practitioners who have not been excluded from Medicare or Medicaid and is used for informational purposes on a facility claim.

Impact

Effective February 1, 2025, any claims billed with an OPR provider number for services rendered independently will be denied for both fee-for-service and Care Management Organizations (CMOs). Please refer to the 'Ordering, Prescribing, and/or Referring (OPR) Providers' message posted in GAMMIS on November 26, 2024.

- OPR providers' NPIs that are billed must be valid and active on the 7400 file and must be registered as an OPR type.
- Attending provider NPIs that are received must be valid and active on the 7400 file and are not required to be registered as an OPR type.
- Providers who are enrolled as an OPR type only, **cannot** be reported as the rendering physician. Claims billed with an OPR type as the rendering provider will be rejected.
- Claims billed with the same physician listed as the rendering provider AND the ordering/referring provider will be rejected.
