PLANNING FOR HEALTHY BABIES (P4HB) MEMBER ID CARDS

Eligible P4HB participants will be enrolled in one of three components of the P4HB family planning waiver program:

1. **Family Planning** – family planning and related services.
2. **Inter-pregnancy Care** – family planning and additional services for women who have delivered a very low birth weight (VLBW, weight < 1500 grams or 3.3 pounds) baby.
3. **Resource Mother Outreach** – assignment of a specially trained case manager to women on traditional Medicaid plans who have delivered a VLBW baby.

Each of the three components has a separate ID card design.
