Relief needs of hourly or shift staff workers should be accommodated by staffing substitutions, plan adjustments, or location changes and not by respite care. Respite isn’t intended to be provided on a continuous, longterm basis where it’s a part of daily services that would enable an unpaid caregiver to work elsewhere full time. Respite is limited to 14 overnight stays per 365 days unless HAP CareSource MI Coordinated Health approves additional time.
