## Summary

The Michigan Department of Health and Human Services (MDHHS) has selected HAP CareSource to offer a combined Medicare and Medicaid plan, **HAP CareSource™ MI Coordinated Health (HMO D-SNP)**, in Macomb and Wayne counties, effective January 1, 2026.

This plan:

- Is a Highly Integrated Dual Eligible Special Needs Plan.
- Is a type of Medicare Advantage plan designed for individuals who are eligible for both Medicare and Medicaid (dual eligibles).
- Has Medicaid benefits, including Long Term Services and Supports (LTSS) and behavioral health services, that are integrated with Medicare benefits, aiming for better care coordination.

## Impact

If you are contracted with **both** HAP Medicare Advantage HMO and HAP CareSource Medicaid, you will be in network for the HAP CareSource MI Coordinated Health (HMO D-SNP) plan beginning January 1, 2026. Your network participation will be governed by your contracts and by the HAP CareSource MI Coordinated Health plan's provider manual, policies and procedures. HAP CareSource MI Coordinated Health replaces the HAP CareSource MI Health Link program, which ends December 31, 2025. Current HAP CareSource MI Health Link enrollees will have the option of moving into HAP CareSource MI Coordinated Health with no break in coverage.
