# **Preferred Diabetic Supply List**

CareSource follows the Indiana Family and Social Services Administration (FSSA) when selecting preferred diabetic supplies for our Indiana Medicaid members. The selected preferred vendors for blood glucose testing monitors, testing supplies and continuous glucose monitors (CGMs) are Roche Diabetes Care, Trividia Health and Dexcom.

The Preferred Diabetes Supply List (PDSL) was created to assist providers and members in selecting preferred blood glucose testing monitors and testing supplies. Updates to the PDSL are published periodically. Table 1 provides an updated list of all products on the PDSL.

## Reimbursement and billing guidance

PDSL claims for all CareSource Indiana Medicaid members must be submitted as pharmacy claims at point-of-sale (POS). **NOTE:** Claims for blood glucose monitors and claims for blood glucose testing strips are not submitted to the same vendor.

### **Blood glucose monitors**

PDSL claims for **blood glucose monitors** must be submitted directly to the PDSL vendors. Table 3 provides the bank identification code (BIN), process control number (PCN), RX Group and ID information required to submit POS claims for blood glucose monitors by vendor type.

PDSL claims for **blood glucose testing strips** for all Indiana Medicaid CareSource members must be submitted using the same ID, BIN, PCN and RX group information used for the members' drug claims.

PDSL claims for **CGMs** for all Indiana Medicaid CareSource members must be submitted using the same ID, BIN, PCN and RX group information used for the members' drug claims.
