## RECITALS

**WHEREAS**, CareSource intends to offer health care coverage through the Indiana Medicaid program\_(the "Product(s)") whereby purchasers of such health care coverage will have access to the network of participating providers contracted by CareSource (the "Network");

**WHEREAS**, CareSource and Provider have engaged in discussions regarding Provider's potential participation in the Network; and

**WHEREAS**, the Parties desire to memorialize their intent to enter into an agreement whereby Provider will participate in the Network (the "Agreement").

**NOW, THEREFORE,** the Parties agree as follows:

- 1. <u>Terms of Agreement</u>. Provided that CareSource offers the Products, the Parties shall work together in good faith to negotiate the Agreement whereby Provider will participate in the Network.
- 2. <u>Definitive Agreements</u>. Execution by each Party of the Agreement as described herein is contingent upon CareSource offering the Products and will then be subject to all necessary consents and approvals, including but not limited, to all required corporate approval of each Party.
- 3. <u>Confidentiality</u>. Each Party will maintain in strict confidence, and will not use or disclose, except as expressly permitted under this Letter of Intent, any confidential information of the other Party.
- 4. **Non-Binding**. Both Parties acknowledge and agree that this Letter of Intent is merely an expression of the Parties' intent and is not a binding contract or a binding agreement to enter into any agreement.
- 5. **Applicable Law and Venue**. Any and all matters of dispute between the Parties to this Letter of Intent shall be governed by the laws of the State of Indiana without reference to its conflict of law principles. Each of the Parties consents to the jurisdiction of the courts of the State of Indiana and agrees that Hamilton County of Indiana shall be the sole proper venue for any litigation or proceeding between the Parties which arises out of or is in connection with this Letter of Intent.
