What is the overall <a href="#">deductible</a> ?	\$6,800 individual/\$13,600 family per benefit year	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay.
