For family coverage, you are responsible for paying the first \$4,000 for covered services for your entire family each benefit year before CareSource begins to pay for any covered service where the Annual Deductible applies. However, for each individual covered member within your family, the maximum amount each member would pay toward the family Deductible is the individual Deductible amount, in this case \$2,000 up to the family maximum of \$4,000. The Annual Deductible applies to covered services identified as “after deductible” in the Covered Service table below.

For family coverage, each individual covered member within your family is contributing toward the family Annual Out-of-Pocket Maximum. However, for each individual covered member within your family, the maximum amount each member would pay toward the family Annual Out-of-Pocket Maximum is the individual Out-of-Pocket Maximum, which is \$6,500. Once a member has reached their out-of-pocket maximum, the plan will pay 100% of their covered services. Your Evidence of Coverage explains which benefits accrue to your Out-of-Pocket Maximum.
