However, for each individual covered member within your family, the maximum amount each member would pay toward the family Deductible is the individual Deductible amount, in this case \$400 up to the family maximum of \$800. The Annual Deductible applies to Covered Services identified as “after deductible” in the Covered Service table below.

For family coverage, each individual covered member within your family is contributing toward the family Annual Out-of-Pocket Maximum.
