However, for each individual covered member within your family, the maximum amount each member would pay toward the family Deductible is the individual Deductible amount, in this case \$1,500 up to the family maximum of \$3,000. The Annual Deductible applies to Covered Services identified as “after deductible” in the Covered Service table below.
