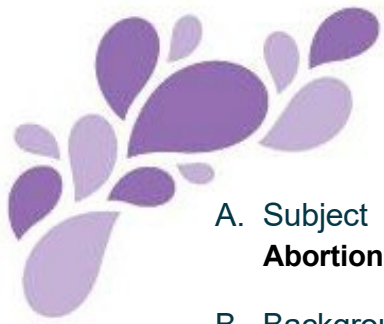

These services meet the standards of good medical practice in the local area, are the lowest cost alternative, and are not provided mainly for the convenience of the member or provider. Medically necessary services also include those services defined in any Evidence of Coverage documents, Medical Policy Statements, Provider Manuals, Member Handbooks, and/or other policies and procedures.

Please refer to the plan contract (often referred to as the Evidence of Coverage) for the service(s) referenced in the Medical Policy Statement. If there is a conflict between the Medical Policy Statement and the plan contract (i.e., Evidence of Coverage), then the plan contract (i.e., Evidence of Coverage) will be the controlling document used to make the determination.

A. Subject
Abortion

B. Background

Abortion is **not** a covered benefit except in the case of a medical emergency.

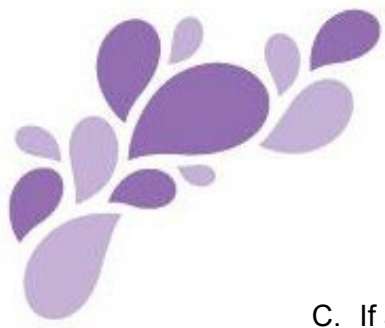
C. Definitions

- **Abortion:** The use or prescription of any instrument, medicine, drug, or any other substance or device with the intent to terminate the pregnancy of a female known to be pregnant. The term "abortion" does not include the use or prescription of any instrument, medicine, drug, or any other substance or device employed solely to increase the probability of a live birth, to preserve the life or health of the child after live birth, or to remove a dead unborn child who died as the result of a spontaneous abortion. The term "abortion" does not include the prescription or use of contraceptives.
- **Medical emergency:** Any condition which, in reasonable medical judgment, complicates the medical condition of a pregnant female as to necessitate the immediate abortion of her pregnancy to avert her death or for which a delay will create serious risk of substantial or irreversible impairment of a major bodily function of the pregnant woman or death of the unborn child. No such condition is to be deemed to exist if it is based on a diagnosis or claim of a mental or emotional condition of the pregnant woman or that the pregnant woman will purposefully engage in conduct which she intends to result in her death or in substantial and irreversible physical impairment of a major bodily function.
- **Unborn child or fetus:** A member of the species homo sapiens from fertilization until birth.
- **Probable gestational age of the unborn child:** The physician's best professional estimate of the probable gestational age of the unborn child at the time an abortion is to be performed.

D. Policy

This policy is written to conform with the Official Code of Georgia.

- I. Abortion is **NOT** a covered benefit except in the case of a medical emergency.
- II. Prior authorization (PA) is required.
 - A. Medical documentation provided must support that the abortion is a medical emergency.
 - B. Evidence of informed consent must be included in the PA
 1. The member must state in writing that **ALL** of the following was provided at least 24 hours before the abortion:
 - a. Medical risks to the pregnant member **AND**
 - b. Probable gestational age and presence of a detectable human heartbeat of an unborn child at the time the abortion would be performed **AND**
 - c. Medical risks associated with carrying the unborn child to term **AND**
 - d. That medical assistance benefits may be available for obstetrical care **AND**



- e. That the father will be liable to support the child **AND**
 - f. How to obtain a ultrasound free of charge **AND**
 - g. Had the right to review printed materials provided by the State of Georgia.
- C. If an ultrasound is performed before the abortion, the member must state in writing **ALL** of the following:
- 1. That they were given the opportunity to view the fetal image and hear fetal heartbeat **AND**
 - 2. If they chose or declined to view the fetal image **AND**
 - 3. If they chose or declined to listen to the fetal heartbeat

III. Reimbursement will not be made for associated services such as anesthesia, laboratory tests, or hospital services if the abortion service itself is not approved through the PA process.

E. Conditions of Coverage

Reimbursement is dependent on, but not limited to, submitting Georgia Marketplace approved HCPCS and CPT codes along with appropriate modifiers. Please refer to the individual Georgia Marketplace fee schedule for appropriate codes.
