Drugs Requiring Professional Administration

For authorization:

All medications that require professional administration by a physician or other healthcare professional must be billed under the medical benefit. These medications will not be available through a retail pharmacy but can be obtained from contracted specialty pharmacies. Contracted specialty pharmacies will bill CareSource under the member's medical benefit, and the member's medical cost share, if any, will apply.
