See your PCP

Are you busy with family, school, work and a host of other things all at once? With all the things we juggle, it's not always easy to remember doctor appointments. And it is important to make them and keep them so you can stay healthy.

Your Primary Care Provider (PCP) is trained to care for most of your health care needs. Even after hours, your provider's office will have a doctor on call who can advise you. Please schedule annual checkups with your PCP. Health screenings can find health problems early and sometimes before symptoms appear.

If you are unable to go to your appointment, please contact your provider. Call the office 24 hours in advance to let them know and reschedule. Remember that you can get rides to medically necessary health care visits when they are covered by CareSource. Just call Member Services at 1-800-390-7102. Choose the menu option for member, then transportation.

'Dual eligible' enrollment to begin this year



The Michigan Department of Community Health (MDCH) will start to enroll members eligible for both Medicaid and Medicare into the Michigan Health Plans. Some people will not be eligible. They include those who:

- ▶ Have a Medicaid Spend-Down
- Are in a long-term care facility
- ▶ Have MI Choice
- Have other health maintenance organization (HMO) coverage

CareSource is happy to prepare for new members. We want to make sure there is a smooth transition for both members and providers. Watch for more information.



Submit your health questions online

Now you have another easy way to contact CareSource 24, our 24-hour nurse advice line. You can fill out an online form to ask a health or medical question at any time. Then just click "Submit." A registered nurse from CareSource will review your question, search for information and call you within 24 hours.

Please do not use this form if you are experiencing symptoms. If you have symptoms or an urgent medical question, please call CareSource 24 to speak with one of our nurses.

Living with severe mental illness

Have you been diagnosed with a severe mental illness? If so, you may be at risk to develop other chronic illnesses such as diabetes, hypertension and cardiovascular diseases.

To change this, you can play an active role in your treatment. You can:

- Get regular physical health checkups.
- ▶ Ask about screenings for conditions such as heart disease, diabetes and high blood pressure.
- ▶ Go to all your scheduled appointments.
- ▶ Tell your doctor if you are not able to take your medicine or follow your treatment plan. Your doctor can help adjust your plan to meet your needs.

Your CareSource case manager can help. He or she will:

- ▶ Explain your benefits for physical and mental health care.
- Help you coordinate your care between your health care providers.
- ▶ Help you prepare questions for your providers before your appointments.
- ▶ Help you get transportation to your appointments.
- ▶ Talk with your providers to make sure you are getting the services you need.

Blood lead testing made easier



Lead poisoning is a danger to children. They can get it from paint, dust, tap water, dirt and other sources. It can cause serious health problems.

Signs of lead poisoning are not always easy to see. That's why children should have a simple blood lead level test at age 1 and 2. Children between the ages of 3 and 6 who have not been tested before should also be tested. CareSource will pay for the test.

You don't always have to go to the trouble of taking your child to a lab to have blood drawn for the test. Some doctors collect a few drops of blood from a finger prick. It can be done right in the doctor's office. Call your child's doctor to make an appointment or to learn more.



Benefit update: Specialty drugs

Some drugs, called specialty drugs, given in your doctor's office now may require prior authorization.

Starting June 15, 2011, your doctor will need to get approval from CareSource first for these specialty drugs. CareSource will work with your doctor to make sure that you get the drugs you need. Your health is always our top priority.

Help prevent the flu: Get a flu shot

Getting a flu shot is the best way to prevent the flu. This year's flu vaccine will contain the same virus strains as last year's. Even so, experts say that getting a flu vaccine every year offers the best chance to be fully protected. They also recommend a flu shot for everyone older than 6 months. If you have questions, talk to your primary care provider.

Benefit statements mailed to members



At CareSource, we have a program to find cases of fraud or abuse in medical billing. And you can help us. Four times a year, we send Explanation of Benefit statements to members. We send them to member households chosen at random.

This is not a bill. These statements show what services were billed to CareSource and how they were paid. They tell you:

- ▶ The member who got the service
- ▶ The provider who billed for the service
- ▶ The date the service was received
- ▶ A description of the service
- The amount paid for the service

If you get a statement, please let us know if you did not get the services shown on it. You can let us know through one of the ways shown below:



CareSource has guidelines for you and your doctor about getting appropriate care. These are guidelines for care recommended by experts and endorsed by us.

We have guidelines for many common conditions. We also have guidelines for preventive care by age and gender. They help guide member health screenings and exams regardless of health status.

Guidelines focus on:

Women's health

- Breast cancer screening
- Cervical cancer screening
- Chlamydia screening
- · Prenatal care
- Postpartum care

▶ Children's health

- Well-child visits (birth-21 years)
 - Lead screening in children
 - Immunizations
- Teen well-care visits

Diabetes care

- Retinal eye exam
- HbA1c testing
- LDL-C screening
- Blood pressure monitoring
- Monitoring for nephropathy

Asthma care

 Use of appropriate asthma medications for people
