However, for each individual covered member within your family, the maximum amount each member would pay towards the family deductible is the individual deductible amount, in this case \$3,000 Medical/\$200 Pharmacy up to the family maximum of \$6,000 Medical/\$400 Pharmacy. The annual deductible does not apply to covered services identified with "No" in the Subject to Deductible column in the Covered Service table below.
