What is the overall <a href="#">deductible</a> ?	\$325 individual/\$650 family per benefit year.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. **Does this plan provide Minimum Essential Coverage? Yes**
