## Summary

This notification outlines changes to NCQA<sup>®</sup> HEDIS<sup>®</sup> quality measures and coding guidance for providing care to pediatric and adolescent members.

## Importance

According to the <u>American Academy of Pediatrics</u>, well visits have proven to be the keystone to providing complete medical services to the pediatric and adolescent population. Certain HEDIS<sup>®</sup> measures look for annual well visits for defined ages and have undergone significant changes for the current Measurement Year (MY). The following table outlines those changes and provides coding guidance. Please refer to the full Pediatric/Adolescent Coding Guide for additional details.
