

Medicare Card Image Approval Process

The Centers for Medicare & Medicaid Services (CMS) made changes to obtaining approval to use the Medicare Card Image and the required updates to the Pre-enrollment checklist.

Process for obtaining approval for the use of Medicare Card Image from CMS

Plans, TPMOs and agents need to:

- 1. Send an email to the marketing mailbox at <u>Marketing@cms.hhs.gov</u> with an attached copy of the material that has the Medicare ID card image on it. An email must be sent for both Marketing and Communication materials.
- 2. Receive either an approval or disapproval from the marketing mailbox.
- 3. For marketing materials, the actual marketing piece and the email permitting the use of the Medicare card image should be zipped and uploaded into the marketing module using the SMID of the marketing piece.
