
BOLO: DSNP First Looks and Roadshows

The Next Generation MyCare program will be implemented in two phases to allow ODM to partner will all stakeholders to prepare for the program expansion and disrupt member as little as possible.

CMS Agent Term & Suspensions List

Effective immediately, CareSource will implement the following actions:

- Before onboarding, CareSource Sales Support
 will compare the requested name against the AB
 Suspension and Termination List. If a match is
 found, the onboarding link will not be sent, and the
 submitting FMO will be notified.
- Each month, we will review the list of actively appointed salespersons and entities against the AB Suspension and Termination List.
- If a match is identified, we will suspend the agent/ agency and place a commission hold on their record, pending the outcome from CMS, who has a selfimposed SLA (Service Level Agreement) of 90 days. A notification will be sent to the agent/agency, with a copy to the upline, informing them that all sales activities must cease until the outcome from CMS is determined.
- Agent/agency that match this list may utilize the appeal methods provided in the notification sent by CMS.
- CareSource has no role in determining who is on the list, the appeal process, length of appeal process, termination date, or the outcome of any case; we will comply with CMS's decisions in all instances.
- If, after 120 days (allowing for unforeseen delays from CMS), the agent/agency remains on the AB Suspension and Termination List, CareSource will terminate the affiliation and all state appointments. The agent's record will be marked as 'Do Not Recontract,' and no further commissions will be paid.
- Conversely, if the agent/agency is removed from the AB Suspension and Termination List after CMS' review, CareSource will lift the commission hold, resume commission payments, including any funds held during the suspension. A notification will be sent to the agent/agency, with a copy to the upline, advising that the suspension has been lifted, sales may resume, and commissions will be paid, including funds held during the suspension period.
