These benefits are effective on January 1, 2019.

The Specialized Recovery Services (SRS) program is available through Medicaid. Individuals eligible for the SRS program will have three new services available through their Medicaid health care coverage, in addition to their current coverage. The services are Recovery Management, Individualized Placement and Support, and

Peer Recovery Support.
