Summary

As of Dec. 31, 2021, CareSource is exiting the Indiana, Kentucky, and Georgia Medicare Advantage markets. These plans will end on Jan. 1, 2022.

In the next few months, CareSource Medicare Advantage members in Indiana, Kentucky, and Georgia will transition to other Medicare coverage.

Impact

Because of this change, it is important to carefully check all patients' ID cards and verify their eligibility before rendering services. As of Jan. 1, 2022, providers should no longer accept the following CareSource Medicare Advantage member ID cards:
